

10th Annual - FCTC Freedom Hunt-2016 ***Application***

You must be one of the following to be eligible to hunt

- 1) Veteran with a 100% disability rating or deemed individually unemployable by the USVA
- 2) Posses a permit from the Michigan DNR to hunt from a standing vehicle
- 3) Considered to be blind by MCL 393.351
- 4) Posses a permit from Mi-DNR to hunt using a laser-sighting device

Fort Custer Training Center in Battle Creek will be hosting a two day gun hunt (October 15 and 16) for whitetail deer for individuals with disabilities. Hunters must apply for this hunt by filling out the application below and sending it along with proof of eligibility (copy of letter from USVA showing 100% disability or individually unemployable, photocopy of MDNR permit to hunt from a standing vehicle or laser-sighting device, paperwork from the State of Michigan proving hunters status as Legally Blind) to.
